[Course aims]

The methods for home care for mentally disabled individuals include the mentally disabled individual gaining the ability to earn a living and the arranging and reconfiguring of the conditions of places involved in their daily life through arranging support networks, such as family members, and utilizing and developing social resources. This course consists of the following three points:

1) Methods for assessing the whole picture of regional life for mentally disabled individuals (ability of the disabled individual to earn a living,

amount of care from family members, connection with the regional lifestyle and culture)

- 2) Methods for assessing and intervening in a variety of dangerous situations encountered during home life
- 3) Considering ways to take advantage of existing social resources necessary for living at home and the nature of legislation and social institutions

from the perspective of reconfiguring an individual's daily life.

[Course objectives]

To gain a deep understanding of the current situation of the regional lifestyle experienced by mentally disabled individuals and of the new assistance methods and resources that are available and to foster the ability to assess the difficulty of an individual's daily life and methods for support rooted in the lifestyle model.
